This document represents data covering the Liverpool City Region – Halton, Knowsley, Liverpool, Sefton, St.Helens and Wirral – the geographic ‘footprint’ covered by the Combined Authority.

Overall Summary

The following document provides an understanding of the Liverpool City Region population according to the protected characteristics including age, disability, sex, race, religion or belief and sexual orientation.

Liverpool City Region population overview (*Mid-year population estimates 2015*)

- The 2014 population estimates place 1.52 million people living in the Liverpool City Region, this is 0.5% higher than the previous year and 2.4% higher than ten years ago.
- Over this ten year period:
 - Liverpool's population increased 6% to 478,600.
 - Halton's population increased 5% to 126,500.
 - Wirral's population increased 2% to 320,900.
 - The population of Knowsley dropped 1% to 147,200.
 - The population of Sefton dropped 1% to 273,700.
 - St.Helens' population increased 1% to 177,600.

Age (*Mid-year Population Estimates 2015*)

- Almost 10% of the Liverpool City Region's population are aged 18 to 24. The district with the highest proportion of young people is Liverpool at 14.2% whilst the smallest proportion is in the Wirral at 7.4% of the population.
- 18.4% of the Liverpool City Region's population are of pensionable age (65 or over); the highest proportion in this age group can be found in Sefton (22.6%) and lowest in Liverpool (14.6%).
- Less than a fifth of the Liverpool City Region's population are aged 0-15 (17.9%) and Halton has the highest proportion at higher than the national average (19.9%).

Disability (*Census 2011*)

- 17.6% of Liverpool City Region residents of working age have a long term limiting illness and almost one in ten (9.2%) are 'limited a lot' in their day to day activities by disability or health problems.

Sex (*Census 2011*)

- Over half (51.2%) of the population of the Liverpool City Region are women and nearly half (48.8%) are men.
- 55.7% of the population that are of pensionable age (65+) are women.

Gender reassignment (*GIRES*)

- An estimated 250 people in the Liverpool City Region will have changed their gender, or be in the process of doing so, to that of their birth.

Pregnancy and Maternity (*Live Births, 2015*)

- Some 17,460 women in the Liverpool City Region were pregnant (in terms of a pregnancy resulting in a birth) during 2015, providing a rate of 60.2 per 1,000 women aged 15-44.

- The maternity rate was highest in Knowsley at 66.5 per 1,000 women (aged 15-44) and lowest in Liverpool (53.9 per 1,000 women aged 15-44, in part possibly influenced by the high student population in the city).

Race (*Census 2011*)

- Over nine in ten (92.2%) of the Liverpool City Region population are White English/Welsh/Scottish/Northern Irish/British.
- Ethnic minority groups make up 7.8% of the Liverpool City Region population, with the largest groups being Other White (1.6%), Irish (0.9%) and Chinese (0.8%).

Religion or Belief (*Census 2011*)

- Almost three quarters (74.1%) of the Liverpool City Region population are Christian.
- Other religious dominations include Muslim (1.3%), Buddhist (0.3%) and Hindu (0.3%) and Jewish (0.2%).
- 17.4% of the Liverpool City Region population state that they have no religion.

Sexual orientation (*Sexual Identity 2015*)

- The Office of National Statistics (ONS) publishes data on self-perceived sexual identity from the APS. Nationally it is estimated that 1.7% of the population are Lesbian, Gay or Bisexual.

Marriage or Civil Partnership (*Census 2011*)

- 40.9% of Liverpool City Region adults described their marital status as 'married', with 0.2% in a same-sex civil partnership.
- In total, 51.3% of adults in the Liverpool City Region were living as a couple; 40.6% as married or in a same-sex civil partnership, with 10.7% cohabiting.
- 2.3% were 'separated', with 7.3% being divorced or a legally dissolved same-sex partnership.
- Some 30.9% were single, and 7.3% were widowed or a surviving partner.

Socio-economic status (*Annual Population Survey, Claimant data, DfE*)

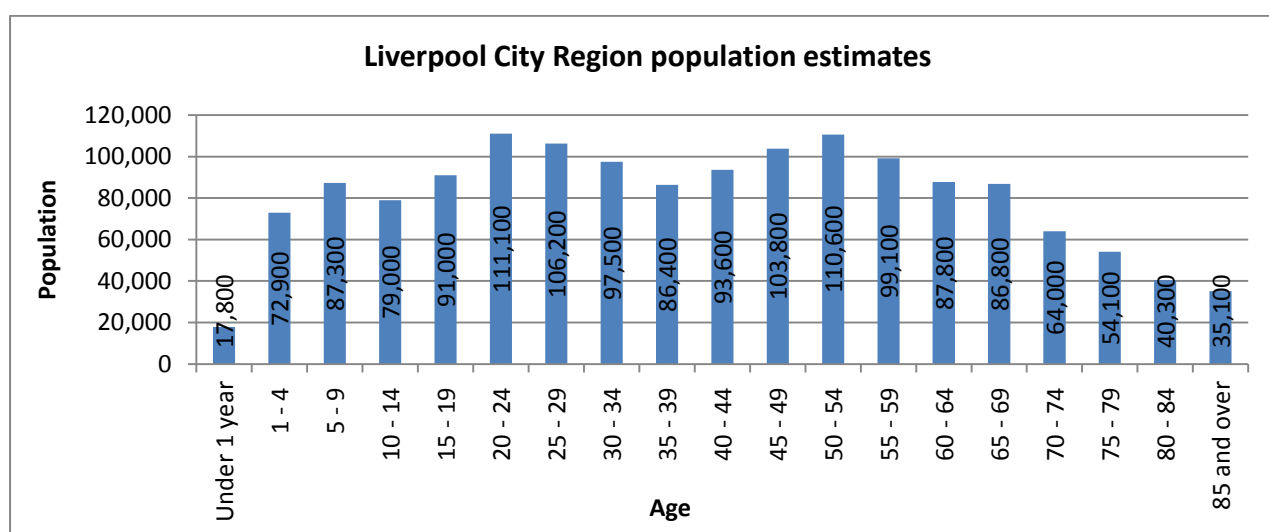
- Almost three quarters (72%) of the Liverpool City Region working age population are economically active.
- 5.5% of the Liverpool City Region working age population are unemployed.
- Currently 2.9% of the Liverpool City Region resident working age population are claiming unemployment benefits (Source: DWP).
- 2,980 (5.7%) young people in the Liverpool City Region (age 16-18) are classed as NEETs – not in education, employment or training (Source: DfE).

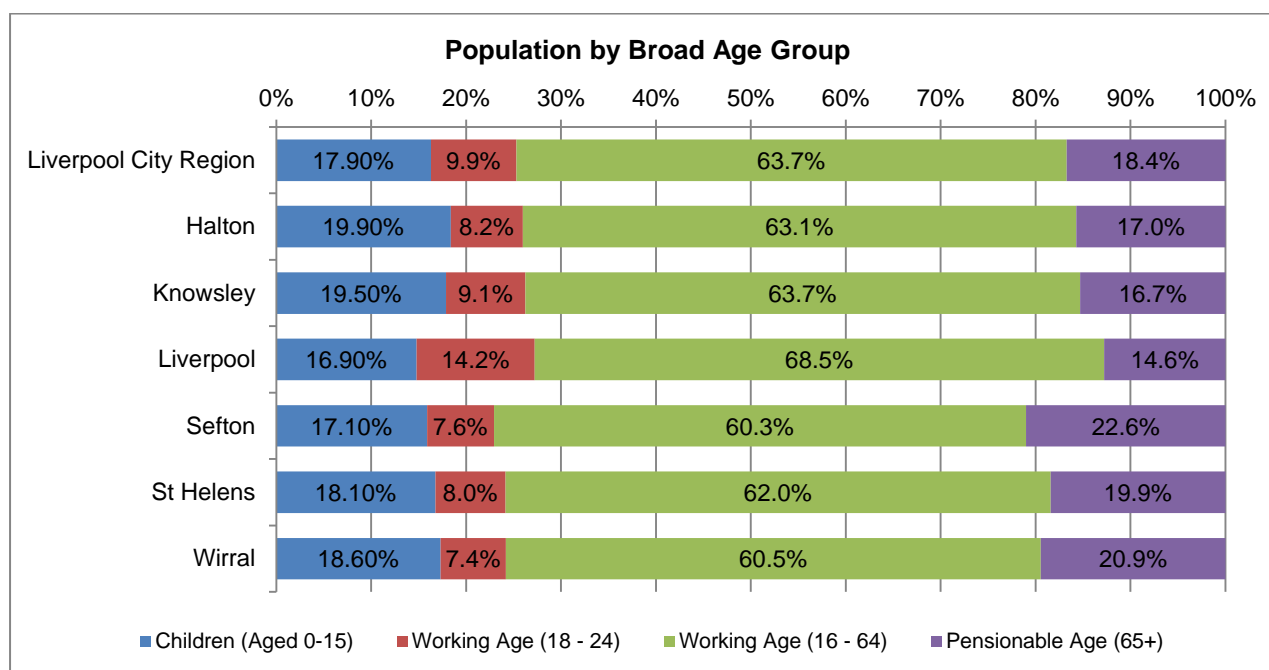

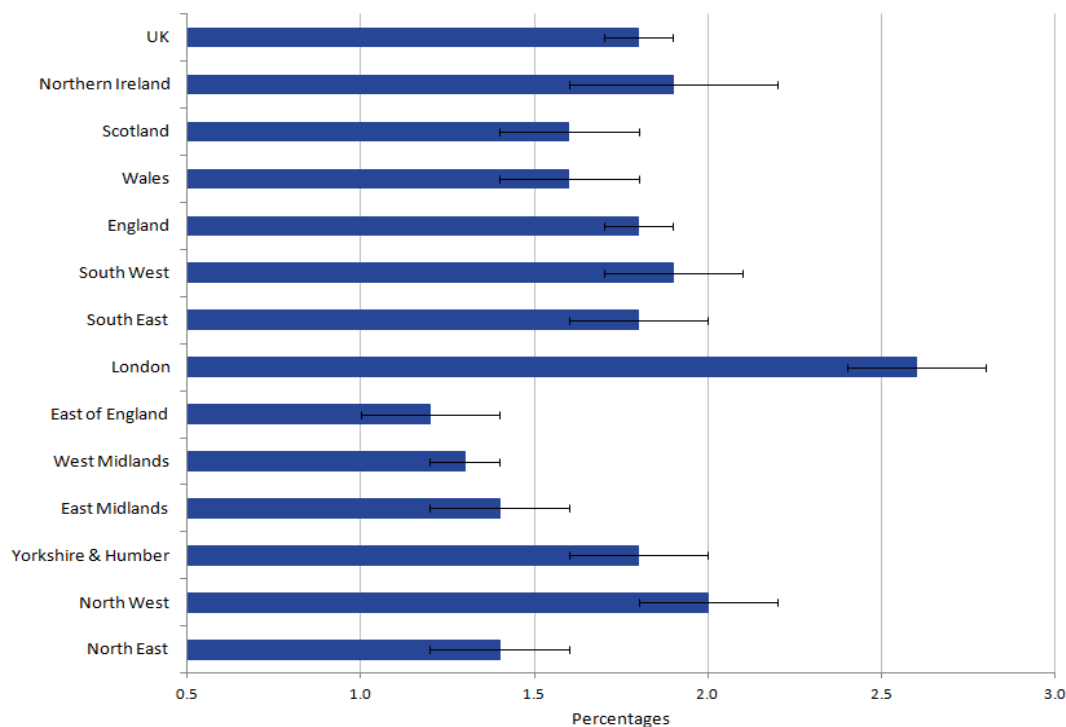

Glossary

APS	Annual Population Survey A quarterly survey conducted by the ONS, presenting a rolling 12 months of data. Questions revolve around economic aspects such as employment and economic activity levels, as well as skills and job grades. Data is available at both residence and workplace levels, with sample sizes typically of 250,000+.
DfE	Department for Education Government department which produces data around issues such as post-age16 skills levels, educational attainment and NEETs. Some data is made available through ONS distribution channels, although more detailed statistics are disseminated through the DfE's website.
DWP	Department for Work and Pensions Government department, producing data around benefits, etc., which is made available through ONS distribution channels.
ESA	Employment and Support Allowance ESA began replacing Incapacity Benefit and Income Support paid on the grounds of incapacity for new claims from the 27th October 2008. Therefore, it is necessary to view this dataset alongside that for Incapacity Benefit/Severe Disability Allowance to gain a full picture. Data for both sets is available on a quarterly basis.
GIRES	Gender Identity Research and Education Society
JSA	Job Seekers Allowance The data represents the numbers of people claiming job-seekers allowance on a monthly basis, and is available at small geographic areas (i.e., below local authority level). As this is the level of claimants, this is not the total number of people unemployed, although it is often used as a coefficient for measuring changes in unemployment levels.
NEET	Not in Education, Employment or Training Common terminology for those aged 16-18 in a low / none level of economic activity. Data is gathered by the DfE and is available at local authority level on an annual basis.
NOMIS	A web-based database of labour market statistics, run by the University of Durham on behalf of ONS. The database provides a portal to many statistical releases, such as the APS, Census, claimant data and mid-year population estimates.
ONS	Office for National Statistics UK official statistical institute, responsible for collecting and publishing statistics related to the economy, population and society at national, regional and local levels
